The Importance of School Buses

- The National Academy of Sciences, U.S. Department of Transportation and other authorities agree that school buses are the safest form of transportation for getting children to and from school
- Buses reduce traffic
 - Each school bus removes an average of 36 cars from the roads
- Buses reduce pollution
 - Buses remove billions of pounds of CO2 emissions yearly
- Buses make school accessible for all
 - For some the only means of transportation to school
- Buses are safer
 - Students are 20x's more likely to arrive at school safely and 50x's for teen drivers


- Covers 5 years (July 2016-June 2021)

 - 2013 30 maximum capacity



Mass 7D Driver License Requirements

- 7D allows "school pupils" to be transported in vehicles other than school buses to and from school with a maximum of eight (8) passengers
- The vehicle must conform with 7D vehicle requirements
- An applicant must be
 - At least 21 years of age
 - Have had a driver's license for three (3) continuous years immediately prior
 - Pass a CORI (Criminal Offender Records Information) check
 - Pass a SORI (Sex offender Registry Information) check
 - Have a satisfactory driving record
 - Pass an eye exam, physical exam and a written knowledge exam

New requirements

- Applications notarized
- 2 hour pre-training requirement
- 8 hour training annually renewal requirement

McKinney-Vento & ESSA Goals

- The goal of the <u>McKinney-Vento Homeless Education Assistance Act</u> is to ensure that each homeless child or youth has equal access to the same free, appropriate public education, including preschool education, as provided to other children and youth.
- The goal of the (ESSA) Every Student Succeeds Act, Title I, part A ensures the educational stability of students in foster care and their equal access to the same free and appropriate public education through high school graduation as provided to other children and youth. Implementation is collaborated with DESE, school districts, and Mass Dept. of Children and Families (DCF)



McKinney-Vento Liaison & POC for DCF

The McKinney-Vento Act requires every school district to designate a Homeless Education Liaison. ESSA requires School districts to designate a Foster care Point of Care staff.

The role of requires assistance in.

- Identification and coordination with school personnel
- Enrollment
- Access to services
- Provide information and referrals
- Refer homeless families to services
- Ensure that students receive the educational services for which they are eligible
- Mediate and resolve enrollment disputes
- Professional development and other support



Transportation

McKinney-Vento

Title I - DCF

- Cost-shared responsibility between districts
- Reimbursement eligible
- IEP With transportation, not cost shared



- Districts must collaborate with DCF to establish policies and procedures to ensure that students who remain in school of origin receive transportation
- When no other agreement can be reached, districts of origin are responsible for providing transportation to/from school of origin
- Districts should document all costs associated with this transportation

McKinney-Vento Grant Parent/Student Support

- FY 2018/2019 \$10,000 1 yr. reduced in half from last FY 18
- The purpose of federal funds is to provide funding for programs that ensure homeless students are enroll in school, attend school, and have the opportunity to succeed in school.

- Assist with fees; books, prom, Capstone, sports
- Summer camp scholarships
