Motion was made by Ms. Flemer and seconded by Mrs. Sheehan to enter into executive session pursuant to M.G.L. Chapter 30A, Section 21 (a)(2): To discuss negotiations relative to union personnel, Assistant Superintendent. A roll call vote was taken and approved 6/0; Dr. Sullivan: YES; Ms. Flemer: YES; Mrs. Curran: YES; Mrs. Nardone: YES; Mrs. Sheehan: YES; Chair Belmarsh: YES. Mayor Hedlund not present.

The Weymouth School Committee met in Executive Session on May 26, 2016, in the Kelly Room at Town Hall. To review discuss strategy relative to negotiations with non-union personnel: Superintendent. The meeting was called to order at 9:00 p.m. by Chair Belmarsh

Also attending: Dr. Salim.

Dr. Salim spoke about Assistant Superintendent Susan Kustka's contract renewal, a 3 year contract from 7-1-16 thru 6-30-19. Would like to add vacation days, vacation days buy-back with accumulated days not used. Will roll in \$1800 for travel. Would bring her from \$125,766 to \$130,521. This comes from \$128,721 plus \$1800 (travel). Discussed that she does an amazing job, wish we could show it in increase. Dr. Salim stated we need to be consistent with increases.

Mrs. Sheehan asked for updated copy of Administrators and Principal salary range charts. Also would like a chart of all Administrators and Principals salary, date of hire, last increase, and contract expirations. Dr. Salim stated he will have for us for the May 31, 2016 meeting.

At 9:14 p.m., a motion was made by Mrs. Sheehan and seconded by Mrs. Curran to adjourn Executive Session and return to open session for the purpose of adjournment.
