## WEYMOUTH SCHOOL COMMITTEE MEETING

Mary J. Livingstone Humanities Center Weymouth High School April 25, 2013 7:00 p.m. MINUTES

The Weymouth School Committee met on April 25, 2013 in the Mary J. Livingstone Humanities Center at Weymouth High School. The meeting was called to order at 7:05 p.m. by Chairperson Sean Guilfoyle with the following members present: Ms. Belmarsh, Ms. Flemer, Mayor Kay, Mrs. Nardone, Mrs. Sheehan and Mr. Ford. Also present were Superintendent Kenneth Salim, Assistant Superintendent Matthew Ferron, Assistant Superintendent Garry Pelletier, and Business Manager Maria Hortaridis

## **Executive Session**

At 7:05 p.m. a motion was made by Ms. Flemer and seconded by Mrs. Sheehan to go into Executive Session for the purpose of discussing strategy in preparation for contract negotiations with union personnel. A roll call vote was taken by Mr. Guilfoyle with the following results: Ms. Belmarsh, YES, Ms. Flemer, Yes; Mrs. Nardone, YES; Mayor Kay, YES; Mrs. Sheehan, YES; and Mr. Ford, YES.

At 7:50 p.m. the School Committee returned to Open Session for the purpose of continuing with the agenda.

The open meeting began with the Pledge of Allegiance to the Flag.

## Approval of Minutes

On motion of Ms. Flemer, seconded by Mr. Ford, it was voted 6-0-1 to approve the Minutes of the March 28, 2013 meeting of the Weymouth School Committee. Mrs. Sheehan abstained as she was not at this meeting.

- Dr. Salim reported on the aftermath of the Boston Marathon Bombing. He stated that he worked with the Central Office Administrators on how to help students. Materials have been provided to the schools and specialists have been consulted.
- 2. Dr. Salim reported on the Special Olympics event that took place on April 24, 2013. There were 110 student athletes and 45 volunteers. He specifically thanked Theresa Skinner, Administrator for Special Education, for her leadership and Betsy Harris for organizing with community partners who helped sponsor this wonderful event.

Ms. Hortaridis reviewed the Monthly Financial Report with the School Committee and that Payroll, Expenses, and Revolving Accounts are all expended appropriately to date.

# Report of Sub-Committees

# Budget Sub-Committee

Mrs. Belmarsh reported that the Budget Sub-Committee has not met since the last School Committee meeting. Mrs. Belmarsh also reported that the full School Committee and the Town Council's Education Committee met on Monday, April 22, 2013 at 6:30 p.m. in Town Council Chambers at Town Hall. Roger Hatch, the Administrator of School Finance with the Massachusetts Department of Elementary and Secondary Education, attended this meeting and explained how Chapter 70 and Net School Spending relates to Weymouth. The Mayor was to submit her budget to the Town Council later that evening. Mrs. Belmarsh reported that the next Budget Sub-Committee meeting will be on May 8, 2013. On motion of Ms. Flemer, seconded by Mr. Ford, it was unanimously voted to accept the report of the Budget Sub-Committee.

# Collective Bargaining Sub-Committee

Ms. Flemer stated that there was nothing to report at this time. Ms. Flemer requested that all union contracts be posted on the Weymouth Public Schools website because they are public documents.

Policy Review Sub-Committee

There was no report.

## **Public Comment**

Kathy Curran expressed her dismay that the School Department is not being funded properly for next year's budget. She urged parents to attend the May 18, 2013 Town Meeting.

Gus Perez expressed his concerns relative to the seriousness of not funding the schools properly in order to meet the Net School Spending deficit. He urged the Town Council Members to work with the Mayor to fund our schools properly. Mr. Perez stated that it has been five years straight that the Town has not met their Net School Spending for the schools. These are facts not opinions. Mayor Kay responded to Mr. Perez's remarks.

Bills Paid

On motion of Ms. Flemer, seconded by Mr. Ford, it was unanimously voted to pay the bills on Warrant #44-2013 in the amount of \$\$740,910.73 with money to pay.

Approval of WPS Regular Education Transportation Contract with First Student
Mrs. Hortaridis reported that the First Student Contract for WPS Regular
Transportation will end on June 30, 2013. An Open Bid Session was held on
March 21, 2013 and we received one proposal from First Student. The annual cost
calculation is as follows:

2013-2014 \$1,787,770.60 2014-2015 \$1,836,960.00 2015-2016 \$1,887,468.40

Mrs. Hortaridis recommended that the School Committee award the Regular Transportation Contract to First Student for a three-year contract beginning July 1, 2013 and ending June 30, 2016. On motion of Ms. Flemer, seconded by Mr. Ford, it was unanimously voted to award a three year contract for Regular Transportation to First Student commencing July 1, 2013 through June 30, 2016.

Confirmation of Action Taken on Field Trip Request by WHS Skills USA Team to Attend State Competition at Blackstone Valley RVTHS, Upton, MA, Aprl-25-27, 2013

Dr. Salim reviewed prior action taken by the School Committee on this Field Trip Request. On motion of Ms. Flemer, seconded by Mr. Ford, it was unanimously voted to confirm this action. Mr. Guilfoyle asked that the Skills Team and Ms. Bowman be invited to the June 16<sup>th</sup> School Committee meeting to report on the competition.

#### **New Business**

- Mr. Guilfoyle requested that Dr. Salim send a letter to Town Solicitor George Lane relative to remote participation at School Committee meetings following a conversation he had with Mayor Kay that Town Council would have to adopt a policy for this. On motion of Mr. Ford, seconded by Ms. Flemer, it was unanimously voted to have Dr. Salim send a letter to Town Solicitor George Lane for this purpose.
- 2. Mr. Guilfoyle reported that summer meeting dates need to be scheduled.
